

ORDINANCE NUMBER 94-04-01  
ADOPTING A COUNTY ENVIRONMENTAL  
SERVICES GROSS RECEIPTS TAX

BE IT ORDAINED BY THE GOVERNING BODY OF GRANT COUNTY:

Section 1. Imposition of Tax. There is imposed on any person engaging in business in the County area outside the boundaries of any incorporated municipality for the privilege of engaging in business in the County an excise tax equal to one-eighth of one percent (1/8 of 1%) of the gross receipts reported or required to be reported by the person pursuant to the New Mexico Gross Receipts and Compensating Tax Act as it now exists or as it may be amended. The tax imposed under this ordinance is pursuant to the County Local Option Gross Receipts Taxes Act as it now exists or as it may be amended and shall be known as the "County Environmental Services Gross Receipts Tax."

Section 2. General Provisions. This ordinance hereby adopts by reference all definitions, exemptions and deductions contained in the Gross Receipts and Compensating Tax Act as it now exists or as it may be amended.

Section 3. Specific Exemptions. No County Environmental Services Gross Receipts Tax shall be imposed on the gross receipts arising from transporting persons or property for hire by railroad, motor vehicle, air transportation or any other means from one point within the County to another point outside the County.

Section 4. Dedication. Revenue from the County Environmental Services Gross Receipts Tax is dedicated for: acquisition, operation and maintenance of solid waste facilities, water facilities, wastewater facilities, sewer systems and related facilities.

Section 5. Effective Date. The effective date of the County Environmental Services Gross Receipts Tax shall be July 1, 1994, three months from the date this ordinance is approved by the Grant County Commission.


WHEREAS, portions of this Comprehensive Plan may at some future time be implemented by Ordinance to facilitate more orderly growth and development in Grant County; and



PASSED, APPROVED AND ADOPTED by the Board of County Commissioners of Grant County, this 16th day of June, 1994.


