ORDINANCE NO. 98-07-23 A
CEDAR HILLS COMMUNITY AREA IMPROVEMENT DISTRICT
ASSESSMENT LEVY

An Ordinance enacted pursuant to the authority of New Mexico Statutes Article 55A NMSA County Improvement Districts, Sections 4-55A-1 through 4-55A-42 NMSA.

BE IT ORDAINED by the Board of County Commissioners of Grant County that :

SECTION I - TITLE

THIS Ordinance may be cited as the Grant County Cedar Hills Community Area Improvement District Ordinance.

SECTION II- DECLARATION OF INTENT AND PURPOSE

PURSUANT to Article 55A NMSA Section 4-55A-3 which authorized Counties to create improvement districts for the public safety, health or welfare, it is hereby declared the purpose and intent of the Board of Grant County Commissioners to enact an ordinance to levy, in accordance with Section 4-55A-18C NMSA 1978 Comp., the assessments contained in the Assessment Roll, which is filed in the office of the Grant County Clerk in Miscellaneous records Book # 250 pages 7744 thru 7746 and is confirmed by Resolution 98-07-09 A, upon the parcels of record named in the Assessment Roll - Cedar Hills Community Area Improvement District,

NOW THEREFORE, it is HEREBY ORDAINED by the Board of Grant County Commissioners that the assessments as contained in the Assessment Roll and as confirmed by Resolution 98-07-09-A shall be levied against the parcels within the Improvement District in accordance with Section 4-55A-18C NMSA 1978 Comp. However, no claim of lien will be filed against any parcel the owner of which has paid in full the amount of the assessment on such parcel, as shown on the Assessment Roll, on or before the fifteenth day after the date of publication or posting of this Ordinance as adopted. Thereafter, all unpaid amounts due will be assessed against all such parcels and claims of lien will be filed of such amounts unpaid.
