

ORDINANCE #O-04-02

AN ORDINANCE IMPOSING A COUNTY FIRE PROTECTION EXCISE TAX IN THE AMOUNT ONE FOURTH OF ONE PERCENT (.25%) OF THE GROSS RECEIPTS OF ANY PERSON ENGAGED IN BUSINESS IN THE UNINCORPORATED AREAS OF THE COUNTY FOR THE PRIVILEGE OF DOING BUSINESS.

WHEREAS, the Board of County Commissioners has determined that fire protection, ambulance services, operational expenses and capital outlay costs for independent fire districts are matters of significant concern to the health, safety, public welfare, character and environment of the County and its inhabitants; and

WHEREAS, the Board of County Commissioners has also determined that fire protection, ambulance services, operational expenses and capital outlay costs for independent fire districts provide significant benefits to the County and its inhabitants; and

WHEREAS, Section 7-20E-15 NMSA (1978) as amended authorize the County to impose an excise tax of one fourth of one percent (.25%) of the gross receipts on any person engaging in business in the County for the privilege of doing business in the unincorporated areas of the County in order to generate revenue for these purposes; and

WHEREAS, Section 7-20E-15 (E) NMSA (1978) as amended requires a vote in favor of the tax by a simple majority of the qualified electors of the County;


NOW THEREFORE BE IT RESOLVED, that the Board of County Commissioners imposes an excise tax of one fourth of one percent (.25%) of gross receipts of any person engaged in business in the unincorporated areas of the County effective July 1, 2005.



**NOTICE OF INTENT TO ADOPT ORDINANCE #O-04-02 A LOCAL
ORDINANCE TO PROPOSE A COUNTY FIRE PROTECTION
EXCISE TAX OF ONE FOURTH OF ONE PERCENT.**

WHEREAS, the Board of Grant County Commissioners finds that fire protection, ambulance services, operational expenses and capital outlay costs of independent fire districts are matters of significant concern to the health, safety, public welfare, character and environment of the County and its inhabitants; and

WHEREAS, the County also finds that fire protection, ambulance services, operational expenses and capital outlay costs of independent fire districts provide significant benefit to the County and its residents; and

WHEREAS, the Board of Grant County Commissioners shall conduct a public hearing on September 28, 2004 at 1:00 p.m. to discuss and receive public input regarding Ordinance #O-04-02; and

WHEREAS, the Board of Grant County Commissioners shall approve or disapprove the adoption of Ordinance #O-04-02 at the September 28, 2004 regular County Commission meeting.

THEREFORE, BE IT RESOLVED, the Board of Grant County Commissioners through the adoption of Resolution #R-04-25 declares its intent to adopt Ordinance #O-04-02, a local ordinance to enact a County fire protection excise tax of one fourth of one percent (.25%).

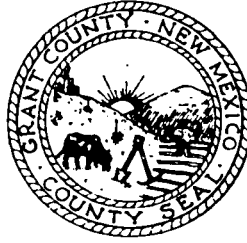



