**WHEREAS**, each Volunteer Fire Department has been established and equipped with sufficient volunteer firefighters and equipment to operate each station and substation (if applicable); and


**WHEREAS**, each Volunteer Fire Department has requested that Grant County revise each of the district boundaries; and


**WHEREAS**, this resolution supersedes all resolutions related to the fire districts for each Volunteer Fire Department.


