

## **RESOLUTION #13-48**

### **A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.**

**WHEREAS**, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Cooperative agreement to patch roadway where needed. Single penetration chip seal with shoulder work and drainage improvements and striping – Kirkland Road – B.O.P. starting at intersection of US-180 SE 1.5 miles to E.O.P. at end of pavement; Cottage San Road – B.O.P. starting at Archer Road intersection north 1.6 miles to E.O.P. at end of pavement; Ridge Road – B.O.P. at intersection of US-180 west 2.44 miles to E.O.P. at end of pavement; Whiskey Creek Airport Road – B.O.P. starting at Kirkland Road intersection South .62 miles to end of pavement and,

**WHEREAS**, the estimated amount of these projects is \$168,507.00 in which the NMDOT will fund \$126,380.00 (75%) and the county will match \$42,127.00 (25%) and,

**WHEREAS**, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and

**WHEREAS**, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.


**NOW THEREFORE, BE IT RESOLVED** by the Board of Grant County Commissioners to enter into Cooperative Agreement project Number CAP-1-14(401). Control Number HW2 L100146 with the New Mexico Department of Transportation for LGRF Project for year 2013 – 2014 to patch roadway where needed. Single penetration chip seal with shoulder work and drainage improvements and striping on Kirkland Road – B.O.P. starting at intersection of US-180 SE 1.5 miles to E.O.P. at end of pavement; Cottage San Road – B.O.P. starting at Archer Road intersection north 1.6 miles to E.O.P. at end of pavement; Ridge Road – B.O.P. at intersection of US-180 west 2.44 miles to E.O.P. at end of pavement; Whiskey Creek Airport Road – B.O.P. starting at Kirkland Road intersection South .62 miles to E.O.P. at end of pavement.

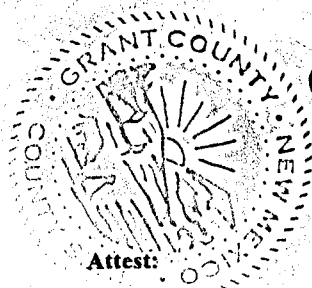
