

RESOLUTION #13-50

A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.

WHEREAS, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Coop Projects to install concrete low water crossings with footings and drainage improvements on McCauley Road – B.O.P. starting 200 feet North of McCauley Road and Bald Knoll Road intersection North 170 feet to E.O.P. and patch - laying single penetration chip seal with drainage and shoulder improvements with striping on Callecita de Oro – B.O.P. starting at Laguna de Oso intersection west .34 miles to intersection of Rio Vista; Galaz Street – B.O.P. at NM 152 intersection North 1.4 miles to E.O.P. at end of pavement; Laguna de Oso – B.O.P. starting at junction of NM 35 West .35 miles to E.O.P. at intersection of Callecita de Oro. and,

WHEREAS, the estimated amount of these projects is \$71,381.00 in which the NMDOT will fund \$53,536.00 (75%) and the county will match \$17,845.00 (25%) and,

WHEREAS, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and

WHEREAS, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.


NOW THEREFORE, BE IT RESOLVED by the Board of Grant County Commissioners to enter into Cooperative Agreement project Number SP-1-14(901). Control Number HW2 L100109 with the New Mexico Department of Transportation for LGRF Project for year 2013 – 2014 to install concrete low water crossing with footings and drainage improvements on McCauley Road – B.O.P. starting 200 feet North of McCauley Road and Bald Knoll intersection North 170 feet to E.O.P. and patch – laying single penetration chip seal with drainage and shoulder improvements and striping on Callecita de Oro – B.O.P. starting at Laguna de Oso intersection West .34 miles to intersection of Rio Vista; Galaz Street – B.O.P. at NM 152 intersection North 1.4 miles to E.O.P. at end of pavement; Laguna de Oso – B.O.P. starting at Junction of NM 35 West .35 miles at intersection of Callecita de Oro.
