Tyrone Subdivision Roads

WHEREAS, a request was received from the developer of Tyrone Subdivision to accept the roads into the county system and

WHEREAS, the roads are located within the boundaries of Grant County in sections 28 and 29 township 18 south Range 14 west N.M.P.M. and the roads by name are:

WHEREAS, the roads are dedicated for public use with a 60 foot right of way as recorded in the Grant County Clerk's Office, book of plats, book 7 pages 35 thru 50 and the combined total road mileage is approximated at 3.83 miles and

WHEREAS, acceptance of Covellite Drive includes the 10.2' drainage structure on the west end of Covellite; and acceptance includes storm and surface drainage improvements beginning at the intersection of Melaconite Avenue and Cuprite Avenue and continuing to Copper Drive; and acceptance includes all storm drain facilities in Copper Drive and Cuprite Avenue and continuing until that system discharges water in Pipe Line Draw; and acceptance includes three small storm drainage systems for Copper Drive east of Chrysocolla Avenue; and acceptance includes a storm drainage system and 15 foot wide drainage easement extending from the east end of Tenorite Court: now

THEREFORE. BE IT RESOLVED that the Board of Grant County Commissioners did accept the Tyrone Subdivision Roads and including the drainage specified above into the County Road System at their regular meeting of April 19, 1990.
