Whereas, this Resolution #90-12-27 rescinds Resolution #90-06-28A and this Resolution #90-12-27 will include all of section 19, 20, & the W1/2 of section 21 in Township 17s Range 10w and will include the E1/2 of section 23 and all of section 24 in Township 17s Range 11w now

THEREFORE BE IT RESOLVED THAT the Board of County Commissioners hereby establishes new boundaries for the Upper Mimbres Fire District to include the River Glen Community and a portion of Casas Adobes and rescinds Resolution #90-06-28A and the new description is as follows:
