Whereas, this Resolution #90-12-27B rescinds any and all previous resolutions and rescinds the "LOWER MIMBRES BICENTENNIAL FIRE DISTRICT, boundaries, (Description) and this Resolution #90-12-27B, LOWER MIMBRES FIRE DISTRICT will no longer include within its' boundaries the following:

the S1/2, S1/2 N1/2, of section 19, the S1/2, S1/2 N1/2, of section 20, & the S1/2, NW1/4, SW1/4 of section 21, in Township 17s Range 10w

and the S1/2, NE1/4, SW1/4 of section 23, the S1/2, S1/2 N1/2 of section 24 in Township 17s Range 11w now?


Map of Boundaries included as "Lower Mimbres Fire District
