DISADVANTAGED BUSINESS ASSISTANCE PROGRAM

A RESOLUTION AFFIRMING THE GRANT COUNTY COMMISSION'S ADOPTION OF THE NEW MEXICO STATE HIGHWAY AND TRANSPORTATION DEPARTMENT'S DISADVANTAGED BUSINESS ASSISTANCE PROGRAM AS WELL AS AUTHORIZING AND DIRECTING THE COUNTY MANAGER TO SET ANNUAL CONTRACTING GOALS.

WHEREAS, the Grant County Commission applies from time to time for federal assistance for improvements to be made at the Grant County Airport; and,

WHEREAS, under Title VI of the Civil Rights Act of 1964 and the Airport and Airways Development Act of 1970 and 49 CFR Part 23 recipients of financial assistance from the Department of Transportation are required to establish programs for the participation of Disadvantaged Business Enterprises (DBE) in federally supported contracting activities; and,

WHEREAS, the New Mexico State Highway and Transportation Department has adopted an extensive program for Disadvantaged Business Enterprises which municipalities may adopt to assure greater efficiency and greater participation of Disadvantaged Business Enterprises in federally supported contracting activities; and,

WHEREAS, recipients are required to establish goals for participation of Disadvantaged Business Enterprises under the terms of the Federal Acts and Regulations as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE GRANT COUNTY COMMISSION:


That the Commission hereby adopts by reference the New Mexico State Highway and Transportation Department's Business Assistance Program dated December 12, 1989, as referenced in SHTD Rule 90-1(L) dated February 14, 1990, as the same may, from time to time, be amended; and

Be it further resolved that the County Manager of Grant County is hereby authorized and directed to establish such annual goals for participation of Disadvantaged Business Enterprises through coordination with the New Mexico State Highway and Transportation Department as may be reasonable in accordance with guidelines and requirements set forth in the applicable Federal and State regulations.


