## TITLE

THIS ORDER may be cited as the BOARD OF GRANT COUNTY COMMISSIONERS PROVISIONAL ORDER #92-11-19, CREATING THE INDIAN HILLS AND LITTLE WALNUT MOBILE RANCH SUBDIVISIONS IMPROVEMENT DISTRICT" and THE CONSTRUCTION OF THE IMPROVEMENT, IN THE INDIAN HILLS & LITTLE WALNUT MOBILE RANCH SUBDIVISIONS IMPROVEMENT DISTRICT."

## THE ORDER

The Board of Grant County Commissioners, by Provisional Order HEREBY ORDERS THE CREATION of The Improvement District cited as "BOARD OF GRANT COUNTY COMMISSIONERS PROVISIONAL ORDER #92-11-19, CREATING The Indian Hills and Little Walnut Mobile Ranch Subdivisions Improvement District and the CONSTRUCTION of the Improvement in the Indian Hills & Little Walnut Mobile Ranch Improvement District" AND

ORDERS THE CONSTRUCTION of the Improvement in the Improvement District as cited "BOARD OF GRANT COUNTY COMMISSIONERS PROVISIONAL ORDER #92-11-19, CREATING The Indian Hills and the Little Walnut Mobile Ranch Subdivisions, Improvement District and THE CONSTRUCTION OF the Improvement in the Indian Hills & Little Walnut Mobile Ranch Subdivisions, Improvement District" AND

The Board FURTHER INSTRUCTS the County Clerk to give notice of the Public Hearing on the Provisional Order, and the notice SHALL:

- 1.) Contain the time and place when the Board shall hold a hearing on the provisional order creating the improvement district;
- 2.) Describe the improvement to be constructed and the general location thereof: and
- 3.) State that any interested person may ascertain in the office of the County Clerk:
  - (a) A description of the property to be assessed: and
  - (b) The maximum amount of benefit estimated to be conferred on each tract or parcel of land.

The County Clerk, shall mail the notice of the hearing on the provisional order to the owner of the tract or parcel of land being assessed the cost of the improvement at his\her last known address. The name and address of the owner of each tract of land shall be obtained from the records of the County Assessor or any other source deemed reliable by the County Clerk. Proof of mailing is to be made by affidavit of the County Clerk, or her Deputy and SHALL be filed in the office of the County Clerk. Failure to mail any notice SHALL not invalidate any of the proceedings authorized in the County Improvement District Act.
