PASSED, ADOPTED and APPROVED by the Board of Commissioners of Grant County, New Mexico, this 9th day of October, 1997.

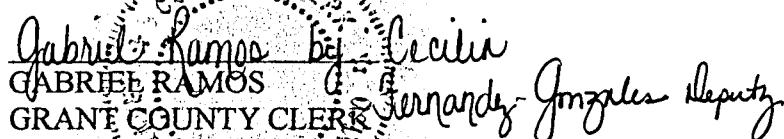

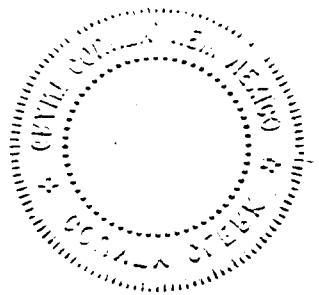
