WHEREAS, the 1998 tax rate for government units sharing in the taxes are in accordance with the Property Tax Code, and;


WHEREAS, Section 7-38-34 requires the Board of County Commissioners issue a written order imposing the tax at the rate set on the net taxable value of property, and;




Dear Chairman Serna:

In accordance with the Property Tax Code (Articles 35 to 38 Chapter 7, NMSA 1978), I hereby set the 1998 property tax rates for the governmental units in your county as reflected in the attached certificate.

You are reminded that Section 7-38-34 of the code requires that within five days of receipt of the order, the board of county commissioners must issue a written order imposing the tax at the rates set on the new taxable value of property allocated in the appropriate government units. In addition a copy of the order must be delivered immediately to the county assessor.




Dear Mr. Harris:
