WHEREAS, in times of scarce resources, it is necessary to find new financing mechanisms and maximize the use of existing resources; and




WHEREAS, this process contributes to local and regional efforts in project identification and selection in short and long range capital planning efforts.


**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY OF GRANT that:**


1. The county has adopted the attached Infrastructure Capital Improvements Plan, and


