WHEREAS, The Grant County Board of County Commissioners did Adopt a Resolution and Ordinance calling for a special election on the County Infrastructure Gross Receipts Tax; and,

WHEREAS, The purpose of this election is to keep the County Juvenile Detention Center operating and certified; and,

WHEREAS, Pursuant to Section 1-24-2(A) NMSA (1978) a Resolution adopting a Proclamation calling for a Special Election must be adopted by the Governing Body,



**LEGAL NOTICE
SPECIAL ELECTION PROCLAMATION**

WHEREAS, pursuant to the Special Election Law of the State of New Mexico, I, Gabriel Ramos, Clerk of Grant County, New Mexico, by proclamation and publication give notice of the election, the object thereof, the question to be voted for, the names of the judges of election, the names of poll clerks, the place where the election is to be held in each of the precincts and election districts.

WHEREAS, it is further provided by the law of the State of New Mexico that said proclamation be filed with the County Clerk and, not less than fifty (50) days before the date of the elections, that the governing body publish the proclamation once each week for two consecutive weeks in a newspaper of general circulation, pursuant to Section 1-24-2 of the Election handbook of the State of New Mexico; and,

WHEREAS, the County Clerk Gabriel Ramos, does deem it expedient that said proclamation be published in the English and Spanish languages; and,

WHEREAS, a Special Election on the NM County Infrastructure Gross Receipts Tax is to be held in the County of Grant on the 25th day of September, 2001; and,

WHEREAS, the elections must be registered in Grant County but outside of an incorporated municipality.

NOW THEREFORE it is proclaimed and ordered by the Clerk of Grant County, State of New Mexico on July 26, 2001, that the County Infrastructure Gross Receipts Tax Special Election will be held on the 25th day of September for the purpose and at the places within said County as hereinafter provided.

The purpose of the said election is to allow registered electors to vote on a question, the question will be listed as follows:

“Shall the Board of County Commissioners impose a one eighth of one percent (1/8 of 1%) of the gross receipts tax in the unincorporated area of the County of Grant for the sole purpose of funding the County Detention center pursuant to Section 7-20E-19(C) (6) NMSA (1978)?”

The Special Election will be conducted pursuant to the Mail Ballot Election Act and all ballots will be mailed to voters.

Persons desiring to register to vote at the special election must register with the County Clerk of Grant County not later than Monday, August 27th, 2001 at 5:00 p.m. the date on which the County Clerk will close the registration books.
