WHEREAS, the County of Grant has experienced a serious financial crisis in the past year; and,

WHEREAS, long term projections indicate the County of Grant will sustain increasing deficits for the next three years; and,

WHEREAS, the New Mexico Department of Finance and Administration has suggested that the first corrective budgetary action should be to reduce elected officials' salaries; and,


WHEREAS, present budget conditions do not allow salary increases for any county employee; and,


WHEREAS, Grant County has previously implemented a resolution calling for salary increases for elected officials;


**NOW, THEREFORE BE IT RESOLVED THAT** The County of Grant hereby rescinds resolution 00-11-28A. This action will result in no increases in salaries for officials elected as of January 1, 2003. This action will also not decrease the salaries of any elected official during their present term of office.

**PASSED, ADOPTED AND APPROVED**, by the Grant County Commission, this 9<sup>th</sup> day of May, 2002.



**ESTABLISHING SALARIES  
FOR COUNTY ELECTED OFFICIALS**

Be it resolved by the board of County Commissioners in and for the County of Grant , State of New Mexico:

Section 1: TITLE AND AUTHORITY. - This resolution may be cited as the "Grant County Elected Officials Salary Resolution" and is adopted pursuant to section 4-37-1 NMSA, Chapter 312 and section 4-44-4.1 NMSA 1978 (Being laws amended 1998 effective January 1, 1999, 2000 supplement)

Section 2: DECLARATION OF PURPOSE.- Article X, Section 1 of the New Mexico constitution requires the legislature to classify counties and fix salaries for county officers. Section 4-44-4.1 NMSA 1978 (Supplement 2000) set the maximum salaries authorized by legislature for the variously classified counties.

It is therefore the purpose of this resolution to establish salaries for elected county officers which do not exceed the maximum salaries established by law.

Section 3: SALARIES. - the following annual Salaries are established for the year beginning January 1, 2000 according to state law, unless changes are made by law that would require an amendment of this Resolution:

- A. County Commissioners, \$17,624
- B. Treasurer, \$43,301
- C. Assessor, \$43,301
- D. Sheriff, \$45,141
- E. Clerk, \$43,301
- F. Probate Judge \$15,141
