Dedication of Area at Bataan Memorial Park
for a Memorial to Vietnam Veterans

WHEREAS, the County of Grant owns and operates a recreational park which has been named in honor of those war veterans who suffered as prisoners of war; and,

WHEREAS, the Grant County Board of Commissioners previously dedicated an area of the Bataan Memorial Park for a Vietnam Veterans Memorial; and,

WHEREAS, the County of Grant has since been asked by the local Vietnam Veterans for additional space in which to develop a larger memorial; and,


WHEREAS, the County of Grant has space at the Bataan Memorial Park, adjacent to the current Vietnam Veteran's Memorial, which will accommodate this request without affecting the other designated uses of the facility; and,

NOW THEREFORE, BE IT RESOLVED by the Grant County Board of County Commissioners, that the area shown on the attached map shall be dedicated for the development of a Vietnam Veteran's Memorial in accordance with the following stipulations:

- 1) The Vietnam Veteran's organization shall bear the costs of designing and developing this memorial, yet this statement shall not prevent the County of Grant from contributing to the project.
- 2) The Vietnam Veteran's organization will design and install four posts indicating the boundaries of the Memorial as shown on the attached map.
- 3) All structures and paths for the memorial shall be designed and constructed in a manner to preserve the existing vegetation and landscape.
- 4) All modifications to the Bataan Memorial Park shall be coordinated with the Grant County Public Works Director.
- 4) The area dedicated for a Vietnam Veteran's Memorial shall remain a part of the Bataan Memorial Park and shall be accessible to all citizens for their common enjoyment.


