WHEREAS, Article X Section 7 of the New Mexico Constitution, as amended, provides that the Board of County Commissioners may be increased from three to five members; and



ORDINANCE NO. O-03-03

AN ORDINANCE ADOPTING A FIVE MEMBER BOARD OF COUNTY COMMISSIONERS; REQUIREMENT OF UNANIMOUS VOTE; PROVISION FOR THE DIVISION OF THE COUNTY INTO FIVE COMMISSION DISTRICTS

WHEREAS, Article X Section 7 of the New Mexico Constitution, as amended, provides that the Board of County Commissioners may be increased from three to five members; and

WHEREAS, the Board of Commissioners of Grant County has determined it will serve the best interests of the citizens of Grant County to expand the Commission; and

WHEREAS, the Board of Commissioners of Grant County desires to enact an Ordinance for the creation of a five member Board of County Commissioners in order to further provide for the safety and general welfare of the citizens of Grant County.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF GRANT COUNTY AS FOLLOWS;

Section 1: Composition of Board. The Board of County Commissioners of Grant County shall be composed of five members elected from five separate commission districts which shall be compact, contiguous and as nearly equal in population as possible.

Section 2: Unanimous Vote. Enactment of this Ordinance shall require the unanimous vote of Board of Commissioners of Grant County.

Section 3: Residency Requirement. One County Commissioner shall be elected from and reside within each district.

Section 4: Length of Terms. All County Commissioners, after having served two four (4) year terms, shall be ineligible to hold any county office for two years thereafter.

Section 5: Districting Requirement. Upon enactment of this Ordinance, the incumbent Board of Commissioners of Grant County shall undertake to divide Grant County into five County Commission districts. All action necessary to complete redistricting shall be completed no later than March 15, 2004 for inclusion in the 2004 Election Proclamation.

Section 6: Severability Clause. If any section of this Ordinance is determined by a Court of competent jurisdiction to be contrary to the Constitution of Laws of the State of New Mexico, that portion shall be severed and, thereafter, be deemed invalid without affection the validity of the remaining sections.

Section 7: Effective Date. This Ordinance shall become law 30 days after recording by the Office of the County Clerk of Grant County.
