

**GRANT COUNTY, NEW MEXICO  
GENERAL OBLIGATION BOND ELECTION  
RESOLUTION NO. R-05-30**

WHEREAS, it is the opinion of the Board of County Commissioners (the "Board") of Grant County, New Mexico (the "County") that, in order to provide suitable and sufficient detention and law enforcement services, a County detention and law enforcement center should be acquired, constructed, designed, equipped, improved and furnished; and

WHEREAS, the Board has determined, on its own initiative, to submit to an election the question of the issuance of its general obligation bonds in the maximum amount and for the purpose hereinafter specified, without the prior filing of a petition by qualified electors; and

WHEREAS, it is the opinion of the Board that it is necessary and in the best interests of the residents of the County that there be submitted to a vote of the registered qualified electors of the County, the question of whether the County should issue its general obligation bonds for the purpose hereinafter specified;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF GRANT COUNTY AS FOLLOWS:

SECTION 1. The Board, on its own initiative, does hereby call a special election to be held in Grant County, New Mexico, on Tuesday, August 23, 2005, at which time there shall be submitted to the registered qualified electors of the County, the following question:

Shall Grant County issue up to \$10,000,000 in general obligation bonds, in one series or more, payable from general (ad valorem) property taxes, to demolish existing structures for and design, construct, improve, equip, and furnish a County Detention and Law Enforcement Center?

SECTION 2. This election shall be conducted by all-mailed ballot in accordance with the Mail Ballot Election Act (Section 1-23-1 to 1-23-7 NMSA 1978). The details of such election shall be provided by separate resolution of the Board.

HENRY TORRES, DIST. 3, CHAIRMAN


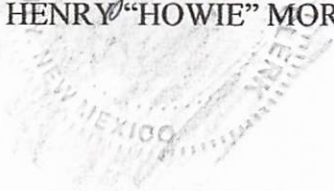
