

RESOLUTION NO. R-05-42

## **Supporting the establishment of a Statewide Transit Fund, and increase in Local Government Road Fund**

**Whereas**, the Board of **Grant County Commissioners** is committed to encouraging alternative modes of public transportation; and

**Whereas**, adequate public transportation promotes quality of life and economic opportunities for many New Mexicans; and

**Whereas**, public transit systems reduce congestion caused by motor vehicle traffic by providing public transportation options for residents; and

**Whereas**, public transportation would reduce noise, air pollution, and negative environmental impacts; and

**Whereas**, the escalation of international and domestic oil and gas prices demand the prudent and responsible use of fuel; and

**Whereas**, public transportation would extend the life of New Mexico's existing roadways by easing the traffic burden; and

**Whereas**, it is not enough to have an efficient state highway system, but rather it is essential that an effective, efficient public transportation system be in place within counties and municipalities in order to provide for the safe and efficient movement of people, goods and services; and

**Whereas**, transportation should be viewed not just as the State highway system, but as a complete network of state and municipal streets, roads, bridges and public transit systems; and

**Whereas**, there is an increasing need to establish a Statewide Transit Fund to match the Federal dollar requirement(s) of the Federal Transit Administration and other Federal funding agencies.

**Whereas**, the **Grant County Commission** has supported other legislation related to enhancing New Mexico public transit expansion; e.g. GRIP

**Whereas**, New Mexico remains one of only six states that does not provide State funding for public transportation; and

**Whereas**, we request that the New Mexico State Legislature appropriate permanent reoccurring funding for public transportation programs


Whereas, this will provide funding for a Statewide Transit Fund and increase the Local Government Road Fund; and


Be It Further Resolved, that the **Grant County Commission**, the Governor and the Legislature work to establish and implement such legislation for the betterment of all New Mexicans.


