WHEREAS, the Village of Columbus located in Luna County is a municipality within the geographical area served by the Group; and,


WHEREAS, the Village of Columbus seeks to participate in the Group as a Voting Member and participant in the Memorandum of Understanding adopted by the Group;

RE: Changes to Memorandum of Understanding

At a recent meeting of the Southwest New Mexico Water Planning Group, the Members voted to seek approval to change the Memorandum of Understanding (MOU). Two changes are requested. First, the Group seeks to add the Village of Columbus to the Group. Second, the Group seeks more formal input from the environmental community by adding a voting member representing an environmental organization. It has been proposed that the Chairman choose the environmental representative. We recognize that other stakeholders may wish to join in the future and we propose to decide on membership on a case by case basis.

The Group seeks your decision as soon as possible.

The specific changes regarding Columbus would be to add ", Columbus" between the municipalities of Bayard and Deming in the first paragraph of the MOU. The same change would be made to the first paragraph of the second page.

The specific change regarding an environmental voting Member would be made in the same paragraphs. The word "and" located between the Hidalgo Soil and Water Conservation District and the San Francisco Soil and Water Conservation District would be removed. Following the San Francisco Soil and Water Conservation District, the words "and an environmental organization selected by the Chairman" would be inserted.

Please consider these issues separately and inform me in writing of the decision by your organization. The work of the Group proceeds well and we appreciate your continued support.
