**Disaster Declaration Due to Flooding**

**WHEREAS**, the County of Grant has experienced significant rainfall during the past month, with two specific storm events creating flooding throughout the county; and

**WHEREAS**, damages to public property from these flooding events have included the loss of three bridges and substantial damage to most roads (both paved and unpaved), and damages to private property have included flooding of fields, structures, and private roadways; and,

**WHEREAS**, Grant County's annual budget does not plan for expenses and services to respond to the extensive damages that have been incurred during these flooding events; and,

**WHEREAS**, Grant County must address the necessary public roadway repairs in the interests of the health, safety and welfare of its citizens;

**NOW THEREFORE, BE IT RESOLVED** by the Grant County Board of County Commissioners hereby declares a disaster in Grant County due to these flooding events, and hereby requests all available assistance from State and Federal resources in addressing the damages incurred, including any assistance that may be provided for those private property owners who incurred damages due to the same flooding events.






