## **RESOLUTION CREATING A TREASURER'S FEE POLICY**

WHEREAS, the Grant County Treasurer's Office incurs costs in processing various transactions as a result of returned personal check and delinquent payments, and,

WHEREAS, it is customary to collect a reasonable fee for the additional work necessary to remedy these problems as allowed by New Mexico State Statute, then,

NOW, THEREFORE, BE IT RESOLVED, that the following fees be implemented for certain transactions within the Grant County Treasurer's Office.

**Return item (NSF) charges** **\$25.00**

This fee will not be less than current bank. This charge will cover the processing cost of returned items.

### **Cost to Grant County-Personal Property(Mobile Home) Sale**

The administration and enforcement of delinquent personal property ad valorm taxes is authorized by New Mexico Statutes 7-38-51 through 56.

The delinquent personal property tax sale is authorized by New Mexico statutes 7-38-57 through 59.

The County Treasurer is authorized to recover any cost incurred in preparing for the sale. To cover additional costs of preparing for the personal property tax sale, the Grant County Treasurer is proposing the following fee:

**Demand Warrant Processing Fee** **\$25.00**

This charge would be for all accounts that are delinquent over 180 days.

**Purchase of Tax Roll to Tax Service Companies** **\$150.00**

This fee will be charged for processing and sending of current tax rolls to Tax Service Companies for payment of taxes through mortgage companies.



PASSED AND APPROVED this 26<sup>th</sup> day of May, 2005, in a regular meeting of the Grant County Commission, Silver City, New Mexico.


