RESOLUTION URGING THE LEGISLATURE TO PASS
THE HEALTH SECURITY ACT

WHEREAS, the health crisis in New Mexico is growing worse: almost one out of four New Mexicans is uninsured and an untold number are underinsured, including many residents of Grant County; and

WHEREAS, premiums are escalating at double digit rates; co-pays are increasing; and pharmaceutical drug costs are rising; all of which cause the number of uninsured and underinsured New Mexicans to continue to rise; and,

WHEREAS, rising health care costs and the lack of health insurance coverage for so many New Mexicans results in a social and economic burden for the affected families, employers, health care providers, the county of Grant and the state of New Mexico; and,

WHEREAS, decreasing the percentage of state and county expenditures on health care will free up funds to be spent in other sectors such as economic development, education, and the environment; and,

WHEREAS, the Health Security Act offers a comprehensive solution enabling New Mexico to set up its own health care plan that would guarantee that all New Mexicans - regardless of age, employment or health status - will have comprehensive, affordable and quality health coverage; and,

WHEREAS, the Health Security Act, by pooling most New Mexicans into one health risk pool, would substantially contain costs, reduce administrative complexity, eliminate uncompensated care; and,

WHEREAS, the Health Security Act would also allow for bulk purchasing of drugs, provide for the protection of retiree benefits, and would be able to reap the benefits of economies of scale; and,

WHEREAS, 117 New Mexico organizations from all parts of the state endorse the Health Security Act;

NOW, THEREFORE, BE IT RESOLVED that the Grant County Commission of New Mexico supports the Health Security Act; and,

BE IT FURTHER RESOLVED that the Grant County Commission will work to ensure passage of the Health Security Act and will urge the NM Association of Counties to make the Health Security Act a legislative priority.



WHEREAS, the commission is continually striving to increase the reserves of the county to be able to provide the best services possible to the citizens of the county; and,


WHEREAS, the commission wishes to do what it can to reduce expenditures in the county, so funds are available for projects and roads;
