RESOLUTION #R-06-21

A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.

WHEREAS, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the County Arterial Program for the full construction of driving surface using PMBP with shoulder maintenance and drainage improvements on Ridge Road from intersection with Bonita Avenue south .55 miles to E.O.P. Full Construction of driving surface with double penetration chip seal on Ridge Road from intersection with US 180 west 1.9 miles to B.O.P. then .5 miles to E.O.P. Fog seal on North Swan Road from Silver City town limits 1.2 miles north to B.O.P. then 1.4 miles to intersection with Niki's Road.

WHEREAS, the estimated amount of these projects is \$211,274.67 in which the NMSHTD will fund \$158,456.00 (75%) and the county will match \$52,818.67 (25%). Vendor# 5114463, Project# CAP-1-07 (451), Control# 87728.

WHEREAS, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and

WHEREAS, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.

NOW THEREFORE, BE IT RESOLVED by the Board of Grant County Commissioners to enter into a cooperative agreement with the New Mexico Department of Transportation for the full construction of driving surface using PMBP with shoulder maintenance and drainage improvements on Ridge Road from intersection with Bonita Avenue south .55 miles to E.O.P. Full Construction of driving surface with double penetration chip seal on Ridge Road from intersection with US 180 west 1.9 miles to B.O.P. then .5 miles to E.O.P. Fog seal on North Swan Road from Silver City town limits 1.2 miles north to B.O.P. then 1.4 miles to intersection with Niki's Road.
