

RESOLUTION #R-06-23

A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.

WHEREAS, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Cooperative Agreement Special Projects for full construction of driving surface with drainage improvements within the Hatchita Townsite from intersection of NM 9 First St., Second St., Third St., Fourth St., and Fifth St., south .15 miles to B St. From intersection with NM 81 A and B Streets .45 miles to intersection with First Street, and

WHEREAS, The estimated amount is \$108,666.67 in which the NMSHTD will fund \$81,500.00 (75%) and the county match will be \$27,166.67 (25%). Vender# 5114463, Project# SP-1-07 (951), Control# 87723, and

WHEREAS, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and

WHEREAS, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.

NOW THEREFORE, BE IT RESOLVED by the Board of Grant County Commissioners to enter into a cooperative agreement with the New Mexico Department of Transportation for full construction of driving surface with drainage improvements within the Hatchita Townsite from intersection of NM 9 First St., Second St., Third St., Fourth St., and Fifth St., south .15 miles to B St. From intersection with NM 81 A and B Streets .45 miles to intersection with First Street.


