RESOLUTION NO. R-07-17

A RESOLUTION IN SUPPORT OF THE FEDERAL PROGRAM PAYMENT IN LIEU OF TAXES ("PILT")

WHEREAS, the federal program known as Payment in Lieu of Taxes (PILT) provides Federal payments to local governments that help offset losses in property taxes due to nontaxable Federal lands within their boundaries; and

WHEREAS, PILT payments help local governments carry out such vital services as firefighting and police protection, construction of public schools and roads, education, solid waste disposal, healthcare, parks and recreation, and search-and-rescue operations; and

WHEREAS, PILT payments are made annually for tax-exempt Federal lands administered by the Bureau of Land Management, the National Park Service, the U.S. Fish and Wildlife Service, the U.S. Forest Service, and for Federal water projects and some military installations; and

WHEREAS, PILT payments are one of the ways that the Federal government can fulfill its role of being a "good neighbor" to local communities; and

WHEREAS, the PILT program is vital to Grant County because the federally owned land totals 1,178,977 acres; and

WHEREAS, New Mexico's Senators Bingaman and Domenici cosponsored a proposal for PILT funding that removes the funding from the annual appropriations process, ensuring that full-funding is automatic through 2012; and

WHEREAS, full-funding for PILT would provide about a 35% increase in total funding for the PILT program; and

WHEREAS, New Mexico is the number one beneficiary of the PILT program receiving \$22.8 million in FY 2006.


NOW THEREFORE BE IT RESOLVED, that the Board of Grant County Commissioners strongly supports legislation that will provide New Mexico counties and the State of New Mexico with full payment of PILT monies; and

BE IT FURTHER RESOLVED, that the Board of Grant County Commissioners urges the Governor, the New Mexico State Legislature, and all counties in the State of New Mexico to work together to support permanent funding for the PILT program.




