

RESOLUTION #R-07-38B

A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.

WHEREAS, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Cooperative Agreement Special Projects for reconstruction, with single penetration chip seal and Drainage improvements on Western Drive from intersection with By-pass Road to .7 miles to intersection with US 180. Reconstruction, with single penetration chip seal and Drainage improvements on Cottage San Road from Silver City Limits north 3.5 miles to end of pavement at intersection with Bear Mountain Road. Engineering Plan for reconstruction of Arena Valley Road from intersection with US 180 2.6 miles looping back to US 180, and

WHEREAS, The estimated amount is \$108,977.33 in which the NMDOT will fund \$81,733.00 (75%) and the county match will be \$27,244.33 (25%). Vender# 54384, Project# SP-1-08 (901), Control# 88180, and

WHEREAS, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and

WHEREAS, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.

NOW THEREFORE, BE IT RESOLVED by the Board of Grant County Commissioners to enter into a cooperative agreement with the New Mexico Department of Transportation for reconstruction, with single penetration chip seal and Drainage improvements on Western Drive from intersection with By-pass Road to .7 miles to intersection with US 180. Reconstruction, with single penetration chip seal and Drainage improvements on Cottage San Road from Silver City Limits north 3.5 miles to end of pavement at intersection with Bear Mountain Road. Engineering Plan for reconstruction of Arena Valley Road from intersection with US 180 2.6 miles looping back to US 180.


