
WHEREAS, The Board of County Commissioners requests to add said roadways to the 2009 Certified County Maintained Road Inventory.

Done, this 18th day of November 2009 at Silver City, Grant County, New Mexico.



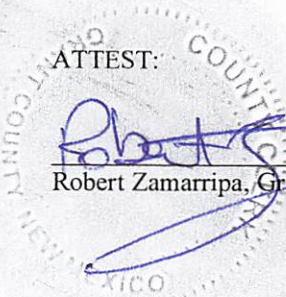

SUBJECT: WIND CANYON ESTATES

B.T. Enterprises would like to respectfully request a final road construction inspection of Phase I, II and III of the Wind Canyon Estates Subdivision. The roads in those three phases have been completed per engineer's plans and we would like to request maintenance of those particular roads to be taken over by the County. The roads we are requesting maintenance for consist of, Camino de Viento, Ventana de Sierra and Mesita Circle. The remaining roads, Wind Canyon drive, Fleming Tank Rd., Babbling Brook rd., Quail Run and Gulch Lane have not been completed. The roads in these two phases still need the base course installed. Enclosed is a bid from Coye Cooper with Earth Services to complete the required base course. His bid in the amount of \$264,000 is less than the two remaining improvement bonds we currently have in place and therefore we would request the release of one of the bonds.
