

RESOLUTION NO. R-10-21

Grant County Volunteer Fire Department Association

WHEREAS, by Resolution No. 91-06-20, the Commissioners of Grant County created a Fire Department Association (“Association”), comprised of the fire chief of each Grant County Fire Department; and

WHEREAS, the purpose of the Volunteer Fire Department Association shall be to plan, coordinate and implement policies of the Board of County Commissioners within Grant County as they apply to the function of fire protection; and

WHEREAS, the Association has been a successful organization, and the Commissioners of Grant County Commissioners with the present resolution intend to support the continued success of the Association; and

WHEREAS, since the Association was created the need for fire protection services has greatly increased and the Grant County Volunteer Fire Departments have expanded; and

WHEREAS, to coordinate the need for increased fire protection services and the expansion of the Grant County Volunteer Fire Departments, Grant County has employed a Grant County Fire Management Officer through federal grant money; and

WHEREAS, the function of the Grant County Fire Management Officer position is to oversee the Grant County Volunteer Fire Departments, at the direction of Grant County Administration; and

WHEREAS, the Commissioners of Grant County have determined the need to redefine the structure of the Association in light of the newly created Grant County Fire Management Officer position; and

WHEREAS, the Commissioners of Grant County have determined that the Grant County Fire Management Officer will be the director of and will oversee the Association; and

WHEREAS, all decisions and recommendations of the Association shall be submitted to the Grant County Fire Management Officer; and

WHEREAS, the Grant County Fire Management Officer shall review all recommendations of the Association to determine how the matter should be addressed; and

WHEREAS, the chairman of the Association shall no longer be the spokesperson charged with submitting all requests to the Commissioners from all the districts within the jurisdiction, but instead the chairman will communicate all requests to the Grant County Fire Management Officer for review; and

WHEREAS, the direction and requirements of Resolution No. 91-06-20 remain in effect to the extent those requirements to not contravene the terms stated herein.


