RESOLUTION NO.R-14-04

AUTHORIZING AND APPROVING SUBMISSION OF A COMPLETED
APPLICATION FOR FINANCIAL ASSISTANCE AND PROJECT APPROVAL TO
THE NEW MEXICO FINANCE AUTHORITY FOR SANTA RITA VFD

Whereas, the County of Grant is a qualified entity under the New Mexico Finance Authority Act, Sections 6-21-1 through 6-21-31, NMSA 1978("Act"), and the Board of Commissioners is Authorized to submit an Application for financial assistance for a building loan for the benefit of the Governmental Unit; and

Whereas, the New Mexico Finance Authority ("NMFA") has instituted a program for providing loans for capital projects and has developed an application procedure whereby the Governing Body may submit an application for a capital project loan from NMFA; and

Whereas, the Governing Body intends to submit an application to build Main Station Fire Department in the Santa Rita Volunteer Fire District, for the benefit of the Governmental Unit and its citizens; and,

Whereas, the application prescribed by NMFA will be completed and submitted on behalf of the Santa Rita VFD and this resolution approving the submission of the application to NMFA for its consideration and review as required as part of the loan application process,

Now therefore be it resolved by the Governing:

Section 1. That all action previously taken by the Governing Body and the Governmental Unit and respective officers and employees in connection with the Application and the Project are hereby ratified, approved and confirmed.

Section 2. That the completed application to be submitted by the Governing Body is hereby approved and confirmed.

Section 3. That the officers and employees of the Governing Body are hereby directed and requested to submit the completed Application to the Finance Authority, and are further authorized to take such other action as may be requested by the Finance Authority in connection with the Application and to proceed with arrangements for financing the Project.

Section 4. All acts and resolutions in conflict with this resolution are hereby rescinded, annulled and repealed.

Section 5. That the loan proceeds will be used to pay all costs associated with the project. This includes cast that have already been expended by the Governing Unity on the project.

Section 6. This Resolution shall take effect immediately upon its adoption.


Section 7. If the loan proceeds will be used to pay all costs associated with the project, this includes cost that has already been expended by the governing body on the project.


