

**RESOLUTION #R-14-06**

**RESOLUTION TO ACCEPT CERTAIN ROADS WITHIN THE WIND CANYON II  
SUBDIVISION, PHASES 4 AND 5, FOR MAINTENANCE**

**WHEREAS**, The Board of County Commissioners (“Board”) desires to accept certain roads for construction and maintenance, within the Wind Canyon II Subdivision during a regular meeting on February 27, 2014; and

**WHEREAS**, The Board previously reviewed and approved in an open meeting held on May 23, 2013, recommendations for improvements to certain roads in Wind Canyon II Subdivision; and

**WHEREAS**, The roads within the Subdivision have been inspected by the Grant County Planning Director in consultation with the Grant County Road Superintendent and have been constructed according to the requirements for construction under the approved variance for materials (May 23, 2013 open meeting), in addition to the standard specifications set under the 1997 Subdivision Regulations for Road Construction; and

**WHEREAS**, The roads to be accepted for maintenance are described as **Gulch Lane** (1.96 miles) from the intersection of Camion de Vente to end of maintenance at corner post; **Babbling Brook Road** (0.28 miles) from intersection of Flemming Tank Road west to end of cul-de-sac; **Flemming Tank Road** (0.87 miles) from address #62 north to end of road; **Wind Canyon** (0.53 miles) from intersection of Gulch Lane west to end of cul-de-sac; **Quail Lane** (0.66 miles) from intersection of Gulch Lane west to end of cul-de-sac; and

**WHEREAS**, The Board of County Commissioners desires to add said roadways to the 2014 Certified County Maintained Road Inventory.

**THEREFORE BE IT RESOLVED** by the Board of Grant County Commissioners that the following roads, Gulch Lane, Babbling Brook Road, Flemming Tank Road, Wind Canyon, and Quail Lane, as further described above, be accepted for construction and maintenance.

**IT IS FURTHER RESOLVED** that the above described roads shall be added to the 2014 Certified County Maintained Road Inventory.


