RESOLUTION AUTHORIZING TRANSFER OF GRANT COUNTY PARCEL NO. 3-070-100-293-378 (1.0 ACRES, MORE OR LESS) TO FREEPORT-MCMORAN CHINO MINES COMPANY

WHEREAS, the Grant County Board of Commissioners ("Commission") desires to acquire a three-acre parcel currently owned by Freeport-McMoran Chino Mines Company (Freeport-McMoran); and

WHEREAS, the Commission desires to use the three-acre parcel for purpose of building a main fire station for the Santa Rita Volunteer Fire Department; and

WHEREAS, Freeport-McMoran desires to acquire a one-acre parcel currently owned by Grant County; and

WHEREAS, the Commission and Freeport-McMoran desire to exchange the parcels under terms substantially similar to the attached draft Exchange Agreement.

A 50.00 FOOT WIDE ROADWAY EASEMENT SITUATE WITHIN THE NW1/4NE1/4 AND THE NE1/4NW1/4 OF SECTION 28, TOWNSHIP 17 SOUTH, RANGE 12 WEST, N.M.P.M., GRANT COUNTY, NEW MEXICO, LYING 25.00 FEET TO THE LEFT AND 25.00 FEET TO THE RIGHT OF THE CENTERLINE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at the Northerly end of the easement herein described, a point on the Southerly right-of-way line of New Mexico Highway No. 152 (Station 243+27.00, O/S 100ft. RL.), from whence the North 1/4 Corner of said Section 28 bears N66°36'50"W, 383.73 feet distant; thence S22°07'33"W, 44.37 feet; thence 178.35 feet along a tangential curve to the right, with a radius of 200.00 feet, through a central angle of 51°05'32" and chord bearing S47°40'19"W, 172.49 feet; thence S73°13'04"W, 129.35 feet; thence 59.94 feet along a tangential curve to the left, with a radius of 100.00 feet, through a central angle of 34°20'35" and chord bearing S56°02'47"W, 59.05 feet; thence S38°52'29"W, 84.67 feet; thence 73.66 feet along a tangential curve to the left, with a radius of 100.00 feet, through a central angle of 42°12'25" and chord bearing S17°46'17"W, 72.01 feet; thence S03°19'56"E, 78.51 feet to a point on the North line of the Hanover Cemetary (wire fence line) and end of the easement herein described, from whence the Northeast Corner of said Section 28 bears N77°54'55"E, 2718.05 feet distant.

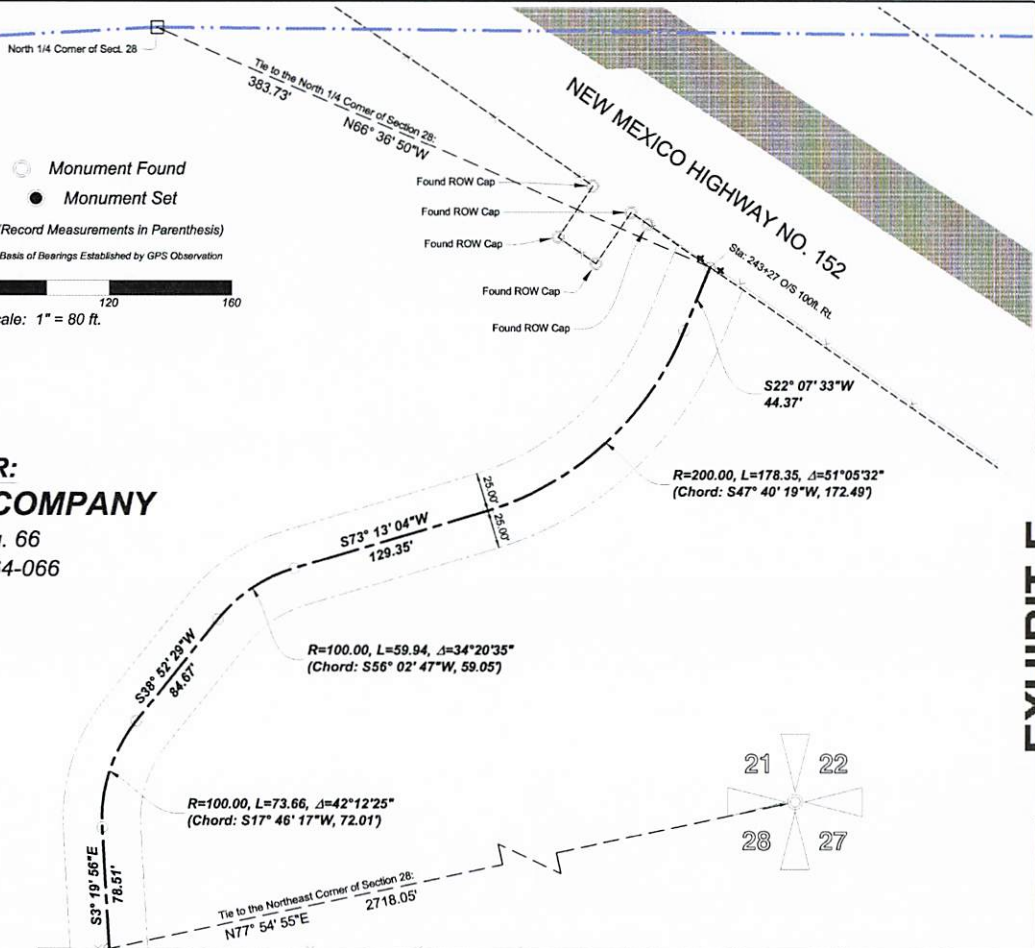
