RESOLUTION NO. R-17-11

**A RESOLUTION DECLARING THE VACATION AND ABANDONMENT
OF STEPHENS ROAD**

WHEREAS, J.T. Hollimon, Ryan Jameson, Stacy Jameson and Jeff Hooker petitioned for the County to abandon certain property commonly known as Stephens Road, located near Buckhorn, New Mexico off of Highway 180 West, beginning at the second cattle guard and ending at or near the wash just past the sixth cattle guard (approximately 2.7 miles), as further depicted on the attached map ("Property");

WHEREAS, there are no public records indicating that the Property was ever dedicated or transferred to the County in any formal or express manner;

WHEREAS, it appears the Property became a public road through prescriptive easement and is being maintained by the County;

WHEREAS, the Grant County Road Superintendent has no objection to the County vacating the Property;

WHEREAS, the Grant County Board of Commissioners appointed a road review committee pursuant to NMSA (1978) § 67-5-4, the members of which reviewed the Property and recommend that the Property is not needed and that the County abandon such Property; and

WHEREAS, the Grant County Board of Commissioners desires to vacate and abandon the Property.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

The Grant County Board of Commissioners hereby vacates and abandons certain property commonly known as Stephens Road, located near Buckhorn, New Mexico, beginning at the second cattle guard and ending at the wash just past the sixth cattle guard (approximately 2.7 miles), as further depicted on the attached map.

It is further resolved that a copy of this Resolution shall be recorded in the Clerk's Office, along with the attached map.


Dear Commissioners:
