

## **RESOLUTION #14-25**

**A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.**

**WHEREAS**, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Coop Projects to install a concrete low water crossing with footings and drainage improvements on Arena Road – B.O.P. starting 0.15 miles East of US-180 intersection 200-feet to E.O.P. and install 90-feet of 6-foot metal culvert with concrete headwalls and drainage improvements on Gage Road – B.O.P. starting 2.5 miles East of the Gage Road/Separ intersection 50-feet to E.O.P. and,

**WHEREAS**, the estimated amount of these projects is \$76,845.00 in which the NMDOT will fund \$57,634.00 (75%) and the county will match \$19,211.00 (25%) and,

**WHEREAS**, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and


**WHEREAS**, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.



Control Number HW2 L100157 with the New Mexico Department of Transportation for LGRF Project for year 2014 – 2015 to install concrete low water crossing with footings and drainage improvements on Arena Road – B.O.P. starting 0.15 miles East of US-180 intersection 200-feet to E.O.P. and install 90-feet of 6-foot metal culvert with concrete headwalls and drainage improvements on Gage Road – B.O.P. starting 2.5 miles East of the Gage Road/Separ intersection 50-feet to E.O.P.


