**A REVISED RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.**

**WHEREAS**, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Cooperative agreement to patch roadway where needed. Single penetration chip seal with shoulder work, drainage improvements and striping on; Apache Street – B.O.P. starting at intersection of Bonita Avenue east 0.64 miles to E.O.P. at intersection of Tabor Drive; South Bear Creek Road – B.O.P. starting at intersection of NM211 East 0.51 miles to E.O.P; Bell Street – B.O.P. starting at intersection of Peterson Drive West 0.23 miles to E.O.P; Cemetery Lane – B.O.P. starting at intersection of NM211 West 0.51 miles to E.O.P; Coleman Drive – B.O.P. starting at intersection with Cottage San West 0.41 miles to E.O.P. at Iron Drive; Cook Street – B.O.P. starting at intersection of Bell Street North 0.11 miles to E.O.P; Hood Street – B.O.P. starting at intersection of Peterson Drive West 0.14 miles to E.O.P; Iron Bridge Road – B.O.P. starting at intersection of US-180 South 0.41 miles to intersection of McCauley Road; Iron Drive – B.O.P. starting at intersection of Coleman Drive Northwest 400ft. to E.O.P; McKinley Street – B.O.P. starting at Peterson Drive intersection West 0.19 miles to E.O.P; Mesa Road – B.O.P. starting at intersection of Arena Road Southeast 1 mile to E.O.P. at intersection of NM211; Oakwood Avenue – B.O.P. starting at US-180 intersection North 0.42 miles to E.O.P; Olympus Street – B.O.P. starting at intersection of Peterson Drive East 0.12 miles to E.O.P; Peterson Drive – B.O.P. starting at intersection of US-180 South 1.07 miles to E.O.P. at intersection of Pike Street; Pike Street – B.O.P. starting at intersection of Peterson Drive West 0.14 miles to E.O.P; Robson Street – B.O.P. starting at intersection of Peterson Drive West 0.12 miles to E.O.P; Six Shooter Road – B.O.P. starting at intersection of Wendy Road South 0.24 miles to E.O.P; Wendy Road – B.O.P. starting at intersection of NM15 East 1.22 miles to E.O.P. and,

**WHEREAS**, the estimated amount of these projects is \$177,092.00 in which the NMDOT will fund \$132,819.00 (75%) and the county will match \$44,273.00 (25%) and;

**WHEREAS**, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated and;

**WHEREAS**, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project and;

**WHEREAS**, this resolution will replace Resolution R-16-21

**NOW THEREFORE, BE IT RESOLVED** by the Board of Grant County Commissioners to enter into Cooperative Agreement project Number CAP-1-17(451). Control Number HW2 L100291 with the New Mexico Department of Transportation for LGRF Project for year 2016 – 2017 to patch roadway where needed. Single

penetration chip seal with shoulder work and drainage improvements and striping on Apache Street – B.O.P. starting at intersection of Bonita Avenue east 0.64 miles to E.O.P. at intersection of Tabor Drive; South Bear Creek Road - B.O.P. starting at intersection of NM211 East 0.51 miles to E.O.P; Bell Street – B.O.P. starting at intersection of Peterson Drive West 0.23 miles to E.O.P; Cemetery Lane – B.O.P. starting at intersection of NM211 West 0.51 miles to E.O.P; Coleman Drive – B.O.P. starting at intersection with Cottage San West 0.41 miles to E.O.P. at Iron Drive; Cook Street – B.O.P. starting at intersection of Bell Street North 0.11 miles to E.O.P; Hood Street – B.O.P. starting at intersection of Peterson Drive West 0.14 miles to E.O.P; Iron Bridge Road – B.O.P. starting at intersection of US-180 South 0.41 miles to intersection of McCauley Road; Iron Drive – B.O.P. starting at intersection of Coleman Drive Northwest 400ft. to E.O.P; McKinley Street – B.O.P. starting at Peterson Drive intersection West 0.19 miles to E.O.P; Mesa Road – B.O.P. starting at intersection of Arena Road Southeast 1 mile to E.O.P. at intersection of NM211; Oakwood Avenue – B.O.P. starting at US-180 intersection North 0.42 miles to E.O.P; Olympus Street – B.O.P. starting at intersection of Swan street East 0.12 miles to E.O.P; Peterson Drive – B.O.P. starting at intersection of US-180 South 1.07 miles to E.O.P. at intersection of Pike Street; Pike Street – B.O.P. starting at intersection of Peterson Drive West 0.14 miles to E.O.P; Robson Street – B.O.P. starting at intersection of Peterson Drive West 0.12 miles to E.O.P; Six Shooter Road – B.O.P. starting at intersection of Wendy Road South 0.24 miles to E.O.P; Wendy Road – B.O.P. starting at intersection of NM15 East 1.22 miles to E.O.P.


