**RESOLUTION#: R14-15**

Viva Santa Rita Subdivision Community Area Improvement District

Filing of the Assessment Roll

WHEREAS Chapter 4 Article 55A NMSA 1978 "County Improvement District Act" (hereafter referred to as the Act) empowers counties to construct improvements as authorized by the Act., and

WHEREAS, the Board of Grant County Commissioners (hereafter referred to as "Board"), in accordance with the Act, section 4-55A-10, created by Resolution#: 13-71 the Viva Santa Rita Subdivision Community Area Improvement District (hereafter referred to as *the District*), for the improvement of Kneeling Nun Road and Miners Legend Road, (hereafter referred to as *the improvement*; and

WHEREAS, the Board by resolution R#:14-13, determined the total cost of the Improvement (\$91,420.00) and elected to construct the improvement and by resolution# R#:14-14, the Board shall assess a portion of the total cost (\$47600.00) against the benefiting tract(s) or parcel(s) of land, and

WHEREAS, the Board in accordance with Article 55A County Improvement Districts section 4-55A-17, is required to prepare and cause to be filed in the Office of the Grant County Clerk an assessment roll for the Viva Santa Rita Subdivision Community Area Improvement District, , containing, among other things:


1. The name of the last known owner of the tract or parcel of land to be assessed, or if his name is unknown, state unknown.
2. A description of the tract or parcel of land to be assessed; and
3. The amount of the assessment against each tract or parcel of land; and


WHEREAS, at this time the filing of aforementioned assessment roll is not a lien upon any tract or parcel of land listed and contained in the assessment roll; and


NOW THEREFORE, the Board by this resolution hereby causes to be filed in the Office of the Grant County Clerk the "Assessment Roll for the Viva Santa Rita Subdivision Community Area Improvement District" and said Assessment Roll is attached hereto and made part of this resolution as exhibit A.

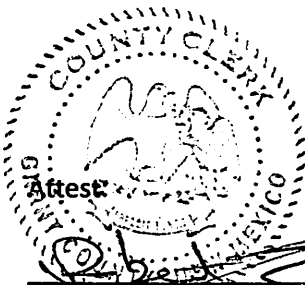


