**A RESOLUTION OF THE COMMISSION OF GRANT COUNTY, NEW MEXICO,
AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY
DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE
DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT
DIVISION; AND AUTHORIZING BRETT KASTEN TO ACT AS THE COUNTY'S
CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL
MATTERS PERTAINING TO THE COUNTY'S PARTICIPATION IN THE
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM UNDER THE
ECONOMIC DEVELOPMENT SET-ASIDE.**

WHEREAS, the need exists within Grant County for economic opportunities, and Grant County desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for Tu Casa Substance Abuse Treatment Facility; and

WHEREAS, the Grant County Commission has held four public hearings to solicit input for the 2016 application funding cycle; and

WHEREAS, the Grant County Commission finds that there is a significant need to undertake the Tu Casa Substance Abuse Treatment Facility to provide adequate services to the community; and

WHEREAS, Grant County will create or retain 1 job for every \$50,000 that will specifically employ low/moderate income individuals for this project;

WHEREAS, Grant County meets and exceeds the dollar for dollar match of private investment; and

WHEREAS, the Grant County Commission determines that the Tu Casa Substance Abuse Treatment Facility meets the requirements of the Community Development Block Grant Program Economic Development Set Aside.

**NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF
GRANT COUNTY, NEW MEXICO, that**

1. The County of Grant is hereby authorized to prepare and submit a Community Development Block Grant Application under the economic development set aside to the NM Department of Finance/Local Government Division for the Tu Casa Substance Abuse Treatment Facility.
2. That the County Commission directs and designates Brett Kasten as the County's Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the County's participation in

the New Mexico Community Development Block Grant Program under the economic development set aside.

3. The Grant County officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution.
4. That the full application will be in the amount of \$500,000.00 for the Tu Casa Substance Abuse Treatment Facility.
5. That it further be stated that Grant County is committing \$2,000,000.00 from its Capital Project GRT Revenue Bond as matching contribution to the Tu Casa Substance Abuse Treatment Facility Project.


