WHEREAS, The Board of County Commissioners hereby certifies that Hanover Cemetery Road has been reduced from 0.51 miles to 0.14 miles.



WHEREAS, The Board of County Commissioners hereby certifies a total of 694.83 miles for the year 2016, herein attached.






