A RESOLUTION AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE COLONIAS INFRASTRUCTURE BOARD FOR THE 2025 COLONIAS INFRASTRUCTURE FUND.

PROJECT: ARENAS VALLEY ROAD IMPROVEMENTS – PHASE III CONSTRUCTION

WHEREAS, municipalities, counties or other entities that accept Colonias funds must adopt certain required federal and state regulations; and

WHEREAS, the County of Grant wishes to ensure compliance with federal and state regulations by applying for funding and allocating funds for the loan component and both Cash and In-Kind match portion of the 2025 Colonias Infrastructure Fund Application; and

WHEREAS, the funds are delivered as 90% grant, 10% loan, 10% cash or in-kind match.

NOW, THEREFORE, BE IT RESOLVED, that the County of Grant is applying for funding and allocates loan component repayment for the \$660,000.00 loan component from the Capital Projects Construction Fund. The Grantee also allocates \$660,000.00 Cash and/or In-Kind as required match component with LGRF approved rates from the Grant County Road Department and Professional Services.


