**A RESOLUTION AUTHORIZING EXPENDITURE OF FUNDS FOR ARCHITECTURAL SERVICES
UNDER EXISTING ON-CALL CONTRACT WITH NCA ARCHITECTS FOR THE PINOS ALTOS
VOLUNTEER FIRE DEPARTMENT (PAVFD) DOS GRIEGOS FIRE STATION**

WHEREAS, Grant County has an existing on-call services contract with NCA Architects for architectural and related professional services; and

WHEREAS, additional services are required for the PAVFD Dos Griegos Fire Station project to ensure proper planning, design, and execution; and

WHEREAS, funding in the amount of \$109,992.75 is available and necessary for the completion of these services; and

WHEREAS, the County Commission has determined that the expenditure of funds for these services is in the best interest of the County and its residents;


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Grant County, that:

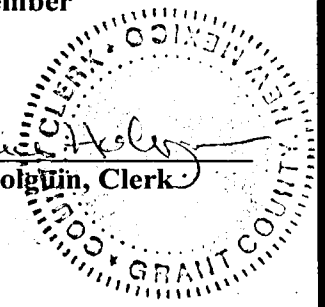
