**A RESOLUTION DECLARING THE VACATION AND ABANDONMENT OF BURCHER  
ROAD NEAR MULE CREEK**

**WHEREAS**, Cindy Spires petitioned for the county to abandon certain property described on the attached plat (hereinafter referred to as the "Property");

**WHEREAS**, although public records do not identify the property as a public right of way, Grant County has been maintaining the property since 1968 according to Road Department Records;

**WHEREAS**, the Grant County Road Superintendent has no objection to the County abandoning the Property;

**WHEREAS**, the Grant County Board of Commissioners appointed a road review committee pursuant to NMSA (1978) § 67-5-4, the members of which reviewed the Property and recommend that the Property is not needed and that the County abandon such Property; and

**WHEREAS**, the Grant County Board of Commissioners desires to abandon the Property.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**

The Grant County Board of Commissioners hereby abandons the Property, as described on the attached plat.

Since the property was never dedicated to the public, the real property remains under the ownership of the adjoining property owners; Spires and the New Mexico State Land Office.

A copy of this Resolution shall be recorded in the Clerk's Office along with the attached plat.






