

**GRANT COUNTY
RESOLUTION NO. R-23-40**

**A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT
BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO
DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF
ROADS WITHIN GRANT COUNTY.**

WHEREAS, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Cooperative agreement to patch roadways and lay single penetration chipseal with drainage, shoulder improvements and striping on the following roads: **Fairway Dr:** BOP starting at intersection of S Ridge Rd going E 1.41mi; **Bonita Ave:** BOP starting at intersection of Lance Dr going S 0.61mi; **Vicente Pl:** BOP starting at intersection of Lance Dr going N & S for a total of 0.20mi; **Country Club:** BOP starting at intersection of Vicente Pl going E for 0.46mi; **Spear Dr:** BOP starting at intersection of Vicente Pl going E for 0.44mi; **Rosewood Cir:** BOP starting at intersection of Copper Ridge going S for 0.15mi; **Deer Trail:** BOP starting at intersection of Cottonwood Rd going E for 0.40mi; **Ponderosa St:** BOP starting at intersection of Pinon St going N for 0.31mi; **Sycamore St:** BOP starting at intersection of Delk Rd going W 0.41mi; **Peterson Dr:** BOP starting at intersection of US-180 going S for 1.07mi; **Escobedo Ln:** BOP starting at intersection of Kirkland Rd going E for 0.47mi; **Morales Rd:** BOP starting at intersection of US-180 going S for 0.50mi


WHEREAS, the estimated amount of these projects is \$222,588.00 in which the NMDOT will fund \$166,941.00 (75%) and the county will match \$55,647.00 (25%); and

WHEREAS, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated; and


WHEREAS, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.

NOW THEREFORE, BE IT RESOLVED by the Board of Grant County Commissioners to enter into Cooperative Agreement project Number CAP2024. Control Number HW2 L100573 with the New Mexico Department of Transportation for LGRF Project for year 2024 to patch roadways and lay single penetration chipseal with drainage, shoulder improvements and striping on the following roads: **Fairway Dr:** BOP starting at intersection of S Ridge Rd going E 1.41mi; **Bonita Ave:** BOP starting at intersection of Lance Dr going S 0.61mi; **Vicente Pl:** BOP starting at intersection of Lance Dr going N & S for a total of 0.20mi; **Country Club:** BOP starting at intersection of Vicente Pl going E for 0.46mi; **Spear Dr:** BOP starting at intersection of Vicente Pl going E for 0.44mi; **Rosewood Cir:** BOP starting at intersection of Copper Ridge going S for 0.15mi; **Deer Trail:** BOP starting at intersection of Cottonwood Rd going E for 0.40mi; **Ponderosa St:** BOP starting at intersection of Pinon St going N for 0.31mi; **Sycamore St:** BOP starting at intersection of Delk Rd going W 0.41mi; **Peterson Dr:** BOP starting at intersection of US-180 going S for 1.07mi; **Escobedo Ln:** BOP starting at intersection of Kirkland Rd going E for 0.47mi; **Morales Rd:** BOP starting at intersection of US-180 going S for 0.50mi
