Fleming Tank Road and Wind Canyon Estates Improvement District Assessment Levy**

WHEREAS Chapter 4 Article 55A NMSA 1978 "County Improvement District Act" (hereafter referred to as the Act) empowers counties to construct improvements as authorized by the Act., and

WHEREAS, the Board of Grant County Commissioners (hereafter referred to as "Board"), in accordance with the Act, section 4-55A-10, created by Resolution # R-16-56 the Fleming Tank Road and Wind Canyon Estates Subdivision Community Area Improvement District (hereafter referred to as *the District*.) for the improvement of Fleming Tank Road and Wind Canyon Road (hereafter referred to as *the improvement*); and





Notice of Intent to Adopt
