

**RESOLUTION No. R-17-05**

**RESOLUTION TO ACCEPT ROADS WITHIN THE OAK COUNTRY ESTATES  
AND THE LOMA VERDE SUBDIVISION FOR MAINTENANCE**

**WHEREAS**, The Board of County Commissioners has accepted the roads within the Oak Country Estates and the Loma Verde subdivision during a regular meeting on February 14th, 2017 and,

**WHEREAS**, The roads to be accepted for maintenance are described as Old Ranch Road (1.20) miles from the intersection of McKinney Road south to intersection of Running Iron Ridge, Running Iron Ridge (0.36) miles from intersection of Old Ranch Road east to end of roadway, Windmill Ridge (0.28) miles from intersection of Old Ranch Road east to end of roadway, Pack Saddle Road (0.20) miles from intersection of Old Ranch Road east to end of roadway; Loma Verde Road (0.85) miles from intersection of Kirkland Road west to intersection of Ventana Drive, Ventana Drive (0.25) miles from intersection of Loma Verde north and south to end of roadway, Acorn Drive (0.30) miles from intersection of Loma Verde north and south to end of roadway, Corto Road (0.13) miles from intersection of Loma Verde Road north and south to end of roadway;

**WHEREAS**, The Board of County Commissioners approve mileage adjustment on Gulch Lane from (0.88) miles to new mileage of (0.90) miles and Wind Canyon Road (0.54) miles to new mileage of (1.60) miles.

**WHEREAS**, The Board of County Commissioners requests to add said roadways to the 2017 Certified County Maintained Road Inventory.

**THEREFORE BE IT RESOLVED** by the Board of Grant County Commissioners that Old Ranch Road, Pack Saddle Road, Windmill Ridge and Running Iron Drive, Loma Verde Road, Ventana Drive, Acorn Drive and Corto Road be accepted for maintenance.
