

RESOLUTION No. R-17-21

A RESOLUTION TO ENTER INTO A COOPERATIVE AGREEMENT BETWEEN THE COUNTY OF GRANT AND THE NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF ROADS WITHIN GRANT COUNTY.

WHEREAS, the County of Grant requests a cooperative agreement with the New Mexico Department of Transportation under the Cooperative agreement to patch roadway where needed. Single penetration chip seal with shoulder work, drainage improvements and striping on Cottonwood Street – B.O.P. starting at west intersection of Main Street 0.16 miles to E.O.P; Hill Street – B.O.P. starting at intersection of Main Street 0.11 miles to E.O.P; Main Street – B.O.P. starting at intersection of North Hurley Road east 0.17 miles to E.O.P; Pop Morrison – B.O.P. starting at intersection of Main Street east 0.07 miles to E.O.P; Agua Blanca – B.O.P. starting at intersection of Horseshoe Loop west 0.19 miles to E.O.P; Geronimo Street – B.O.P. starting at intersection of North Hurley Road west 0.16 miles to E.O.P; Horseshoe Drive – B.O.P. starting at intersection of North Hurley Road east 1 mile to E.O.P; Monte Vista – B.O.P. starting at intersection of North Hurley Road northeast 0.13 miles to E.O.P; Mum Street – B.O.P. starting at intersection of North Hurley Road north 0.09 miles to E.O.P; North Swan – B.O.P. starting at intersection of Mt. Olympus north .47 miles to E.O.P; Aleco Way – B.O.P. starting at intersection of Vesuvius Way north 0.10 miles to E.O.P; Vesuvius Way – B.O.P. starting at intersection of North Swan east 0.54 miles to end of road; Chimboraza Point – B.O.P. starting at intersection of North Swan 0.13 miles to end of road; Himalaya Way – B.O.P. starting at intersection of North Swan west 0.06 miles to end of road; Rosedale Road – B.O.P. starting at City Limits sign south 0.96 miles to E.O.P. and Rosedale Road – B.O.P. starting at intersection of Elder Lane south 1.3 miles to E.O.P; North Hurley Overpass Road – B.O.P. starting at intersection of North Hurley Road northeast 0.69 miles to E.O.P; Market Street – B.O.P. starting at US-180 intersection east 0.37 miles to City Limits sign; Escobedo Lane – B.O.P. starting at intersection of Kirkland Road east 0.46 miles to E.O.P; Arenas Valley Road – B.O.P. starting at west intersection of US-180 2.6 miles to east intersection of US-180.

WHEREAS, the estimated amount of these projects is \$165,188.00 in which the NMDOT will fund \$123,891.00 (75%) and the county will match \$41,297.00 (25%) and,

WHEREAS, funds, equipment, labor and materials representing the County's share will be available when the agreement becomes effective, and will remain readily available until agreement is completed or legally terminated, and

WHEREAS, funds representing the County's share of the agreement will be budgeted for, available and payable upon completion of the project.

NOW THEREFORE, BE IT RESOLVED by the Board of Grant County Commissioners to enter into Cooperative Agreement project Number CAP-1-18(401). Control Number HW2 L100340 with the New Mexico Department of Transportation for LGRF Project for year 2017 – 2018 to patch roadway where needed. Single penetration chip seal with shoulder work and drainage improvements and striping on Cottonwood Street – B.O.P. starting at intersection of Main Street 0.16 miles to E.O.P; Hill Street – B.O.P. starting at intersection of Main Street east 0.11 miles to E.O.P; Main Street – B.O.P. starting at intersection of North Hurley Road east 0.17 miles to E.O.P; Pop Morrison – B.O.P. starting at intersection of Main Street east 0.07 miles to E.O.P; Agua Blanca – B.O.P. starting at intersection of Horseshoe Loop west 0.19 miles to E.O.P; Geronimo Street – B.O.P. starting at intersection of North Hurley Road west 0.16 miles to E.O.P; Horseshoe Drive – B.O.P. starting at intersection of North Hurley Road east 1 mile to E.O.P; Monte Vista – B.O.P. starting at intersection of North Hurley Road northeast 0.13 miles to E.O.P; Mum Street – B.O.P. starting at intersection of North Hurley Road north 0.09 miles to E.O.P; North Swan Street – B.O.P. starting at intersection of Mt. Olympus north 0.47 miles to E.O.P; Aleco Way – B.O.P. starting at intersection of Vesuvius Way north 0.10 miles to E.O.P; Vesuvius Way – B.O.P. starting at intersection of North Swan east 0.54 miles to end of road; Chimboraza Point – B.O.P. starting at intersection of North Swan north 0.13 miles to end of road; Himalaya Way – B.O.P. starting at intersection of North Swan west 0.06 miles to end of road; Rosedale Road – B.O.P. starting at City limits sign south 0.96 miles to E.O.P. and Rosedale Road starting at intersection of Elder Lane south 1.3 miles to E.O.P; North Hurley Overpass Road – B.O.P. starting at intersection of North Hurley Road northeast 0.69 miles to E.O.P; Market Street – B.O.P. starting at US-180 intersection east 0.37 miles to City limits sign; Escobedo Lane – B.O.P. starting at intersection of Kirkland Road east 0.46 miles to E.O.P; Arenas Valley Road – B.O.P. starting at west intersection of US-180 2.6 miles to east intersection of US-180.
