AUTHORIZING THE EXECUTION AND DELIVERY OF A GRANT AGREEMENT BY AND BETWEEN GRANT COUNTY, NEW MEXICO (THE "GOVERNMENTAL UNIT") AND NEW MEXICO COUNTIES, 2020-2021 WILDFIRE RISK REDUCTION GRANT PROGRAM FOR EDUCATION PROJECT TITLED: GRANT COUNTY EDUCATION, PREVENTION AND OUTREACH PROJECT IN THE AMOUNT OF \$10,000 WITH A 10% MATCH.




